Principle: Māori cultural interests are understood and respected.

Why?

Maori are the tangata whenua of this land. They, and their interests, have been marginalised and disregarded for too long. Any extraction of mineralls should only happen with greater input by iwi and hapu.

Principle: Support the transition to a carbon neutral economy by 2050.

Why?

This is critical. We need the rapid phase-out of fossil fuel extraction (including no more permit extensions, a halt to deep-sea drilling and fracking). The importance of a rapid and just transition to a carbon neutral economy by 2050 cannot be understated. The longer we delay, the less comfortable such a transition will be.

Principle: The impact on people, communities and regions are managed in a just and inclusive way.

Why?

We must make the changes to a carbon neutral economy in a just and inclusive way. This includes a just transition for the working people and communities whose jobs currently rely on fossil fuel extraction. The Government needs to support working people and unions to train for new careers in clean industries. It would be utterly immoral and unconscionable for us to allow those with privilege and resource to buy their way through' to do so at the expense of those without.
